
CITI Training Help Guide – Social Behavioral Researchers

This help guide contains directions for setting up CITI training account and enrolling in courses for Social and Behavioral Researchers

1. Navigate to https://about.citiprogram.org/ and click Register.



2. Type in Organization Affiliation "Arizona College of Nursing" and check boxes agreeing to the terms of service a privacy policy and affirming you are an affiliate of Arizona College of Nursing. Then click *Create a CITI Program account*.
